Ingredient: Patchouli oil. Essentail oil from leaves of several species. Since this is a natural steam distilled essential oil prepared from *Pogostemon calbin*, exact components of the minor components may vary. Major constituent is patchouli alcohol; minor constituents include patchoulene, azulene, eugenol, and several unidentified sesquiterpenes.
